With support from Washington's National Park Fund, Mount Rainier was able to fund their volunteer program, improve/enhance trail maintenance and campgrounds, strengthen their search and rescue program, and bring more youth into the park for programs.

4b (Code: ) (Expenses \$ 350,809. including grants of \$ 251,166.) (Revenue \$ )

With support from Washington's National Park Fund, Olympic National Park was able to fund beach clean-ups, restore historical films, fund the restoration of fishers within the park, and provide opportunities for NatureBridge youth and interns in the Elwha River region. We also provided funding for a ranger at the Forks Ranger Station for the summer.

With support from Washington's National Park Fund, North Cascades National Park was able to bring in youth from the tribes and nearby communities for special programming. They also funded trail improvements, hired Student Conservation Assoc. and WA Conservation Corps trail crews, and purchased additional gear for their Search & Rescue program.
